ESEA Arbitration Update

ESEA entered into arbitration on April 10-12th for the 2017-2018 contract year. Now, the arbitrator must render his decision based on both ESEA and CCSD's best and final offer. Best and final offers from both sides were submitted mid-June. A ruling is expected by no later than the beginning of the 2018/2019 school year.

Additionally, ESEA is now preparing to negotiate the 2018-2019 contract. Bargaining sessions will begin by the beginning of the 2018/2019 school year. We launched a CBA Survey last May and we have had an overwhelming response. Over 1,100 survey entries were submitted. We will be revealing the results of the survey during the 1st week of July.

NV Supreme Court: EMRB vs. ESEA

The Nevada Supreme Court heard oral arguments on June 13th regarding the EMRB's decision to certify a vote challenging ESEA's exclusive right to represent and bargain for CCSD support professionals. Briefs were submitted by both legal teams and each side was given 15 minutes to present their oral arguments. To listen to each presentation visit the following link:
